

**FANDANGO'S DOUBLE OR NOTHING SWEEPSTAKES ("Sweepstakes")**  
**OFFICIAL RULES ("Official Rules")**

**NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**YOU MUST BE 21 YEARS OF AGE OR OLDER TO ENTER.**

The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants ("Participants") agree to be bound by these Official Rules and the decisions of Fandango Media, LLC ("Sponsor"), which are binding and final on matters relating to this Sweepstakes.

**SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION:** Winner is subject to verification of eligibility requirements, including verification of age. The potential winner of the Grand Prize (defined below) is referred to herein as the "Winner".

**GRAND PRIZE (1):** There is one (1) grand prize ("Grand Prize") available to be awarded, to one (1) Winner. Winner will receive an ultimate country club experience for a three (3) day, two (2) night trip for Winner and one (1) guest ("Guest") to San Francisco, CA. In no event will the Released Parties be liable for more than the stated number of prizes in these Official Rules. **CHOICE OF LAW AND JURISDICTION:** All federal, state, and local laws and regulations apply. Void where prohibited by law. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any Participant and the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the state of California without giving effect to any choice of law or conflict of laws rules (whether of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than California.
